Looking at military marriages within the telescoping contexts of the state, their regimental and civilian communities, and the couples themselves, The Girl I Left Behind Me reveals the range of masculinities beneath the uniform, the positive influence of wives and sweethearts on soldiers' performance of their duties, and the surprising resilience of partnerships severed by war and army anti-marriage policies.

The correspondence from the large private practices of James Jurin, George Cheyne, and William Cullen opens a unique window on the doctor-patient relationship in England and Scotland from this period. Elizabeth Singer Rowe and the Development of the English Novel-Paula R. Bakscheider 2013-03-29

Bakscheider looks to archival materials, literary analysis, biographical evidence, and a configuration of cultural and feminist theories to prove her groundbreaking argument.
